



CUSTOMS REQUIREMENTS

EU CITIZENS

If client lived less than 12 months outside of the European Union, the shipment is subject of duties and taxes.

If client lived more than 12 months outside of the European Union, the following documents are required :

1. Itemised valued inventory list in categories: furniture - electrical appliances - dishes, etc. we will translate it for you.
2. Work certificate from the employer of the origin country, proving the client worked there for more than 12 months.
3. Copy of client's visa of the origin country or copy of the rental contract of the apartment of the origin country.
4. Copy of residence permit or of the rental contract showing the client's address in Hungary.
5. Work certificate from the Hungarian employer stating dates and purpose of moving to Hungary.
6. Legible copy of passport.
7. Authorization for AGS to deal with the customs clearance in Hungary: we will provide you with this form.

FOREIGN (NON EU) CITIZENS (EXPATRIATES)

1. Itemised valued inventory list in categories: furniture - electrical appliances - dishes, etc. we will translate it for you.

Important:

Each electrical appliance must appear with its 1.) mark 2.) model 3.) serial number

Of the paintings customs requires photograph or a short description of the painting (stating size, painter and what shows)

2. Original bank guarantee (it is based on the valued inventory). AGS will calculate the amount of the bank guarantee.
3. Copy of residence permit or of the rental contract of the apartment in Hungary, proving the client's address in Hungary.
4. Copy of the work permit or work certificate from the employing firm stating dates and purpose of moving to Hungary.
5. Legible copy of passport.
6. Authorization for AGS to deal with the customs clearance in Hungary: we will provide you with this form.

For foreign expatriates there is no definitive customs clearance in Hungary. Admission is allowed for the period of validity of the residence permit. When this permit expires, an additional clearance procedure must be effected or the shipment has to leave Hungary. This additional clearance is not included in our price, but we can assist if needed.



CUSTOMS REQUIREMENTS FOR DIPLOMATS

- 1.) Duty free customs form provided by the Embassy here in Hungary stamped by the Embassy and the Protocol department in the Ministry of Foreign Affairs
- 2.) Inventory list provided by the Embassy in Hungary (in Hungarian also) stamped by the Embassy and the Protocol department in the Ministry of Foreign Affairs
- 3.) Copy of the client's passport
- 4.) Authorization for AGS to deal with the customs clearance in Hungary: we will provide you with this form.

CUSTOMS REQUIREMENTS FOR RETURNING HUNGARIAN CITIZENS

1. Original certificate from the Hungarian Consulate abroad, certifying that client has been living abroad for more than 12 months.
2. Itemized valued list of the personal effects in Hungarian with values in HUF.
3. Copy of passport.
4. Hungarian identity card renewed or reissued by local Hungarian Police Authority (called SZEMÉLYI KÁRTYA)
5. Certification from the local Town Hall stating the address of the client in Hungary (called LAKCÍMKÁRTYA)
6. Tax card showing tax number (called ADÓKÁRTYA)
7. Declaration from the client stating that 1.) in the last six months before his shipment's arrival there have not been made any customs clearance for him 2.) and that he is in possession of the HHGS for more than six months. We will provide you with this form.
8. Authorization for AGS to deal with the customs clearance in Hungary: we will provide you with this form.

Since customs laws and their interpretation are subject to change, we cannot guarantee that further documentation will not be required from you by customs officials. In such a case, we will advise you as soon as possible.

In case of possessing a car :

- all the above mentioned documents
- the car must meet the European technical standards

Please note that returning citizens can import the car duty-free, but there is still one tax which they have to pay : this is the registration tax. This depends on the year, size of the engine, type of the engine, etc., and can vary from 800 to 8000 EUR.
