USEFUL INFORMATION

- House goods are duty free if owned and used for a minimum 6 months.
- Import of electrical items, DVD, VCD or video are restricted.
NOTE: Please notify and obtain advise from us on preparation of this type of shipment on inventory list for smooth clearance.
- Liquors, wine, whisky are allowed & duty free for approx. 1 - 2 bottles per family.
- We offer "Orientation & Welcoming" services including home, school, clubs, etc. Can be tailored to meet the needs of corporate clients or individuals.
- As a value added service, we can arrange & offer "Meet & Greet" services which encompass hotel reservations, airport transfer and a day tour. This service must be requested in advance prior to arrival.

DOCUMENTS REQUIRED

- Sea Shipment - Bill of Lading, inventory list and passport copy. Custom clearance takes between 3 - 5 working days.
- Air Shipment - AWB copy, inventory list and passport copy. Custom clearance takes between 1 - 2 working days.
- All required documents must reach our office at least 3 days prior to shipment's arrival.
- Our Advantage - we are a Licensed Custom Clearance & have Bonded Warehouse which enables us to custom clear with or without shipper in the country. However, shipment to different states e.g Penang / Brunei requires owner's passport for verification purpose.

PET

- A flat rate of **USD 400.00** including 7 days quarantine per pet.
- To apply import permit, please fax clear copies or scan via e-mail - rabbles, health certificate, vaccine records with pet's details e.g. colour, age, breed, and flight information at least 3 days prior to arrival.
- Permits are available upon request.
- Quarantine in East Malaysia & Brunei is from 30 days to 180 days. Our quarantine fee after the 7th day quarantine is **USD 1.50** per day per pet.
- No food provided. Please ensure pet's food is supplied together with cage/kennel.
- Visiting Hours - during normal office hours. After office hours are subject to approval.

CAR / MOTORCYCLE

- A flat rate of **USD 485.00** includes complete clearance, port / THC fee and delivery via Car Carrier from port to residence.
- IMPORTANT** - mandatory requirement for all importers to apply personally at the Ministry of Int'l Trade and Industry (MITI) to obtain Approval Permit (AP).
- Documents required - JK 69 application form, original passport & copies, original ownership or de-registration & copies, original receipts & copies (duty & tax purpose), insurance policy copies (use previous country) and working visa for foreigners.
- Approval takes between 7 - 21 days subject to all documents are in order.
- Duties from 120% - 300% and sales tax at 10%.
- Malaysian Diplomat - 50% off from duties.
- No duties - for Foreign Diplomats and special program i.e. "Malaysia My 2nd Home" and "Malaysian Professionals Returning" subject to approval and additional documents as required.

STORAGE

- Storage charges at port due to improper documents or late received documents will be at cost.
- Storage or SIT charges at our facilities including warehousing handling for in/out are as follows:-
